Housing Independence Through Employment (HITE) will provide Rapid Rehousing services in scattered-site housing throughout Westchester County, New York. It will have 2.5 grant-funded Employment Case Managers who provide intensive employment-focused services including comprehensive psychosocial needs assessment, case management, quarterly reassessments, advocacy, crisis intervention and life skills training. The Case Managers will link participants to the full array of mainstream health, mental health, chemical dependency, financial, family support, and informal support services they need.

The Employment Case Managers will be responsible for coordinating each participant's progress through an individually tailored vocational training process primarily funded through Westhab's new DSS employment contract. The employment services available through this DSS program include a comprehensive vocational, development of an Individual Employment Plan based on this vocational assessment, STRIVE Attitudinal Training and Job Readiness Preparation, a Community Work Experience Program, Job Placement, and Job Retention services. HITE's CoC-funded Employment Case Managers will monitor where each participant is in the process and work to ensure that they are effectively and fully engaged in all activities specified in their Individual Employment Plan.

A full-time Job Developer specifically assigned to this project will help identify job opportunities matched to each HITE participant's employment needs and strengths.

Westhab will provide matching funds in the form of additional employment services for HITE participants, which will be provided by Westhab's new DSS employment contract. This will include two half-time STRIVE work readiness trainers and 0.198 FTE of Westhab's Director of Employment Services, Joanne Dunn, to ensure that the CoC-funded services for HITE participants are appropriately coordinated with Westhab's DSS-funded, NYS- funded, and privately-funded employment services and all needed employment and self-sufficiency resources available from other agencies. Westhab's other match will be two half-time Housing Retention Workers being funded through its STEHP contract with NYS OTDA.

Westhab's successful strategy for maximizing the effectiveness and cost-efficiency of its Rapid Rehousing resources is to offer shallow rent subsidies, which it expects to average \$300 per month per participant in this program. This enables Westhab to help more people and also makes it more feasible that participants will be able to manage without the ongoing CoC subsidy after 24 months or less in Rapid Rehousing. Using this strategy will enable HITE to serve 60 households annually, who will be a mix of single individuals and families.



This modifies our letter of the above date in which we stated that you would be treated as an organization that is not a private foundation until the expiration of your advance ruling period.

Your exempt status under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3) is still in effect. Based on the information you submitted, we have determined that you are not a private foundation within the meaning of section 509(a) of the Code because you are an organization of the type described in section 509(a)(1) and 170(b)(1)(a)(vi).

Grantors and contributors may rely on this determination unless the Internal Revenue Service publishes notice to the contrary. However, if you lose your section 509(a)(1) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or tailure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(1) organization.
