This Rental Assistance project administered by the City of Mount Vernon provides housing for 3 disabled homeless veterans from Mount Vernon in 3 scattered-site one-bedroom apartments. Preference will be given to Mount Vernon's homeless veterans who are chronically homeless. We will use a Housing First approach to offer eligible participants immediate access to permanent supportive housing.

This initiative is conducted in collaboration with the VA and the Mount Vernon Veterans Service Agency. 
