In addition to housing, participants are provided with linkages to a variety of treatment and other supportive services, service coordination, emotional support, and monitoring of their compliance with recommended treatment regimens. This model of SRO housing with on-site support services, including case management, 24-hour client care monitors, and a community living environment is most beneficial for the chronically homeless population we serve.


