The Family YMCA at Tarrytown provides 48 SRO units for single men. 46 of these units are restricted to low income occupancy by contractual obligation. Ten of the 46 units are specifically dedicated to occupancy by men with disabilities who meet the HUD definition of homelessness with disabilities coming from Westchester County emergency shelter system. This application is requesting funding to cover the operating cost of the 10 SRO units to provide permanent housing to homeless single men with disabilities. To assist residents maintain their housing, the YMCA will leverage COC funds by paying social services staff to provide supportive services.

Proposed Methodology: The YMCA will accept referrals from the Westchester County Department of Social Services Homeless Unit Emergency Shelters. Single homeless men mental illness, substance abuse and or medical condition shall be eligible for occupancy of the 10 units to be reserved for this program. Upon acceptance, each resident will be assigned to a furnished room on permanent basis and make a contribution of \$285 per month. This YMCA will pay the salary of social service staff to provide supportive services. The social service staff will conduct a psychosocial assessment and formulate a service plan specific to the needs each resident.

Services shall include but not limited to: Obtaining better housing and housing retention, income aintenance, establishment of benefits residents who qualify for, psychiatric stability, abstinence from drugs and alcohol, medical care, increase employability through employment counseling and or referral, enhanced social and independent living skills. This YMCA has linkage agreement with a number of community agencies to ensure residents obtain full range of services. Proposed Outcomes: At least 10 residents will receive and maintain permanent housing at the Family YMCA at Tarrytown for the period under consideration At least 10 residents will receive on going supportive services and counseling, referrals, Independent living skills and support counseling. At least 90% of 10 residents will abstain from drug use, maintain physical and psychiatric stability. All employable residents on Public Assistance will receive employment counseling and referrals. At least 2 residents will obtain better permanent housing and move out. 90% of residents will maintain current level of income. 10% will achieve enhancement benefits, 100% unemployable residents on PA will apply for SSI/SSD 10 residents will improve their social and independent living skills.


